Open National Invitation to Tender No.001/AONO/SNH/CIPM/2024 of 22/05/2024 for the replacement of generator of the main building of the head office of the National Hydrocarbons Corporation in Yaoundé, Mfoundi Division, Center Region, Cameroon

1. Subject of the Tender

The National Hydrocarbons Corporation (SNH) hereby launches a National Open Invitation to Tender for the replacement of generator of the main building of the head office of SNH in Yaounde, Mfoundi Division, Center Region, Cameroon.

2. Number of lots

This Invitation to Tender comprises one (01) lot.

3. Conditions for participation

Participation in this Invitation to Tender is open to national companies or groups of national companies, with proven experience in the supply and installation of generators for buildings open to the public.

4. Funding

The services under this Invitation to Tender will be funded by the 2024 Budget of the National Hydrocarbons Corporation.

5. Consultation and acquisition of Tender File

The Tender File (TF) may be consulted and obtained during working hours, upon publication of this Invitation to Tender, at the Secretariat of the Public Contracts Unit of the SNH, located at its head office building in Yaoundé.

The TF can be obtained from the said secretariat upon presentation of a payment receipt of a non-refundable sum of **two hundred thousand (200 000) CFA Francs into account N°335 988 of the "Compte Spécial CAS ARMP"**, opened at one of the following twelve (12) branches of the "Banque Internationale du Cameroun pour l'Epargne et le Crédit" (BICEC): Yaoundé-Central Branch, Douala-Bonanjo, Buea, Ebolowa, Dschang, Ngaoundéré, Maroua, Limbe, Bafoussam, Bamenda, Garoua and Bertoua.

6. Deadline for the acquisition of the Tender File

The deadline for the acquisition of the Tender File is **Friday 14th June 2024 at 3pm, local time.**

7. Pre-bid meeting and visit of the project site

In order to ensure that bidders understand all the aspects of the project and the context in which it is carried out, SNH shall organise a pre-bid meeting and a site visit with the companies that have purchased the Tender File **on Wednesday 19th June 2024 at 02:00 pm, local time**, at the SNH Head Office in Yaounde.

Companies that have purchased the TF are invited to participate in these activities, and the related costs are to be borne by them.

Participation in the pre-bid meeting and in the entire duration of the visit to the project site is compulsory, failing which SNH will not issue a visit certificate.

8. Submission of bids

Each bid, drafted in French or English, in seven (7) copies including one (1) original and six (6) duplicates labelled as such, must be submitted in

a sealed envelope to the Secretariat of the Public Contracts Unit of SNH, P.O. Box 955 Yaoundé, Tel.: (237) 222 20 98 64, Fax (237) 2 22 20 98 69, **latest on Wednesday 03rd July 2024 at 02:00 pm**, local time. The bids submitted against receipt, must be labelled as follows:

9. Bid bond

Under penalty of rejection of the bid, each bidder must include in the administrative documents a bid bond of **five million CFA Francs (5 000 000 XAF)**, issued by a first class bank or financial institution accredited by the Ministry in charge of Finance to issue bid bonds within the framework of public contracts.

The validity period of the bid bond is one hundred and twenty (120) days with effect from the deadline for the submission of bids.

10. Admissibility of bids

Under penalty of being rejected, the required administrative documents must be submitted in originals and copies certified as true by the issuing services or competent administrative authorities.

They must be dated less than three (3) months before the deadline for the submission of bids.

Any bid not compliant with the requirements of this Invitation to Tender and the Tender File shall be declared inadmissible, notably the absence of a bid bond or failure to comply with model documents of the Tender File.

11. Opening of bids

The bids shall be opened in one phase.

The opening of administrative, technical and financial offers will take place on **Wednesday 03rd July 2024 at 03:00 pm local time**, by the Internal Tenders Board of SNH.

Only bidders or their duly appointed representatives with perfect knowledge of the bid for which they are represented may attend the opening session.

12. Duration of execution

The maximum duration set by SNH for the conduct of works under this invitation to tender is **six (06) months.**

13. Evaluation of bids

* Elimination criteria

a. Incomplete administrative file, technical or financial bid, or non-compliance (including that of the members of the Group, if applicable) of one of the documents;

b. False declaration, substitution or falsification of administrative, technical or financial documents;

c. Absence or non-compliance of the bid bond

d. No duration for the execution of the project or duration longer than the maximum prescribed duration;

e. Services proposed by the Bidder not compliant with technical specifications;

f. Technical score less than 80/100;

g. Absence of proof of having already executed at least one (01) contract for the supply and the installation of generators for a building open to the public, during the last five (05) years;

h. In the event of a consortium, absence of proof for one of the Members of the consortium of having already carried out at least one (01) contract for the supply and the installation of generators for a building open to the public, during the last five (05) years.

* Essential criteria for evaluating technical offers

2	Methodology proposed by the bidder for the execution of the project	10 points
3	Experience of the bidder in the execution of contracts for the supply and the installation of generators for a building open to the public, within the last five (05) years	45 points
4	References of the key personnel proposed by the bidder to execute the project, in the installation of generators for a building open to the public	40 points
Technical score (Ts)		100

14. Award of the Contract

After evaluation, the Contract shall be awarded to the bidder whose bid is assessed as the «lowest bid», meaning the cheapest, and technically qualified (score greater than or equal to 80/100).

15. Validity period of bids

Bidders shall remain bound by their bids for a period of ninety (90) days, with effect from the deadline for the submission of bids.
